- **501(c)(3) Organizations:**
  - Provide a copy of the filed 2018 Federal Form 990, or 990 EZ, or 990-N E-filing receipt.
  - If entity is on a fiscal year, then provide a copy of the filed 2017 Federal Form 990.
  - If entity is on a calendar year and filed an extension, then provide a copy of the filed Federal Form 8868 and 2017 Federal Form 990.
- **Churches:**
  - The IRS Group Ruling Tax Exemption Determination Letter.

**Deadline** to submit paperwork:

- Charity Recipient Application form - immediately
- Non-profit verification paperwork: May 31, 2019
